- -also issue about keeping excel sheet up to date
- a) It is division directors responsibility to keep and collect all paperwork and forms to turn in afterwards to NCTTA
- -David feels it is useless to collect an excel sheet prior to receiving big bulk
- -Willy feels it is useful to collect an excel sheet to double check what is coming in and what is not as Division Directors do NOT know what is going on all the time
 - -bigger issue as to why do they not know
- -other bigger issue of what to do with January 1st if only a few divisions survive the deadline....to extend it or stand strong with fewer schools?
- -Liang speaks up and gives point of view of buffer week
- -also create incentive to turn in forms on time, says competitive schools have incentive, but others do not Issue NOT resolved.
