Previous meeting minutes approved 7-0-0 May 2013 Meeting started at 8:01pm EST.

1. Mini Committee on League Schedule structure

- -Jasna Rather-TX Division; Fede-Coach's Committee; Brayden Glad-Audit committee, Presley-GA Division
- -Committee has met once and will meet a couple more times and WL will submit findings to the board for consideration in July

2. NIRSA-Recruitment book

- -WL asks board to purchase NIRSA professional membership to use member directory to recruit schools and even potentially look at making a push at Intramural table tennis competition
- -WL will see what is difference between NIRSA professional membership or student membership to see which is better for NCTTA

3. Division & Regional Updates

- -discussion ended with the Canadian divisions

5. Athlete Survey

- -KL 143 responses, majority are current athletes
- What did we learn?
- a) How do schools pay for NCTTA? Almost ½ from schools which could correlate that NCTTA could raise membership dues since we are one of the cheapest member dues
 - -WL would like to see RK's financial area where to raise dues, look for that in July
- b) Recruitment
 - Recruitment is based on the where and the what, where in the US and what either public or private institution (WL)
- c) Women in Table Tennis
 - -suggestion of schools to lower overall number to 3 and allow a different women's format
 - -WL, KGL, CW and others agree to NOT change the format; we are a TEAM organization
 - -JEW says why not continue to recruit the men's teams b/c they are the ones recruiting the women anyways
- d) How much competition is enough?
 - The majority wants more competition and a large majority are also playing in USATT and CTTA competition.
 - -KL will post all comments on hub of athlete surveys
- e) Full time requirement
 - more full time then part time
 - a number of replies against the full time option causing economic issues
 - Bottomline NCTTA could go to a full time requirement; it would be ok
- f) Alumni League
- -Andy K mentions why not having an Alumni tournament at Nationals or Regionals or Division level
- Lots of different ideas floating around in this area, but an overwhelming support for Alumni league or tournament

Logistic for giving away Butterfly prizes and to whom

- -KL will select 2 folks for 50 dollar Butterfly Gift Certificates
- -JEW or WL will follow up with Butterfly on how it is distributed

6) Committee Chair/Member terms

- -Fede presents an idea to give Coach's committee and other NCTTA committees a structure: to allow for specific composition; how to be a part of a committee, how many years members and chairs can be involved, how many years on a term
- -KGL says it doesn't have to be in the bylaws, b/c Committee chairs and BOD have a good working structure. Rules create a political mechanism that may not be needed in NCTTA
- -WL can you submit an outline, when will you start this, how will it work with the Coaching committee being the guinea pig to see how this works

- -WL annoyed that no one has stepped up to do the Alumni committee as there are 3-4 individuals that have signed up for the committee. Will address the Alumni committee with outline of what committee should be doing
- -Discussion about the LinkedIn possibility of NCTTA creating a group to add to its social media presence.

7) USATT table at US Open

- -Fede will CC WL to see how that is done
- -a way to put NCTTA on the USATT map with brochures, etc.

8) PR Etc. proposal to "Brand" NCTTA

- -WL spoke with Ed H about branding NCTTA Championships
- -BOD didn't see tangible elements or metric that was measureable
- -JEW suggested using a McFarland type of commission idea vs spending this money outright (counter proposal)
- -BOD rejected both a counter proposal and the current proposal as it is out of our budget
- -JEW brought up a conversation with Fede from Microsoft that could look at bringing corporate money and talking with people that have experience in this area

9) August Face 2 Face mtg

-CW has found some locations for mtg space in Milwaukee for a mtg for Saturday evening and Sunday

10) NCAA and NCTTA's position

- -We would all like it, but we don't have enough schools committed to it
- -RK we think the status would be good, but the conditions/requirements levied by the NCAA would be very strict and difficult to comply with
- -WL we don't have the manpower to pursue it at this point in time
