1.	<p>NCTTA Rating – RK – 9:05p</p> <ul style="list-style-type: none"> • Frequency of updating player’s rating <ul style="list-style-type: none"> ○ currently we do a one-time rating sync to USATT rating at the beginning of the NCTTA season ○ thereafter, we update player’s ratings based on results from NCTTA tournaments only ○ syncing rating to USATT rating mid-season would nullify a player’s performance in the NCTTA season and potentially lead to people taking advantage of the system • Achieving more accurate rating <ul style="list-style-type: none"> ○ need more play – some players complained about lack of play ○ leverage USATT rating + membership number (on danserver) ○ make NCTTA tournaments sanctioned by USATT – tabled for later ○ for players who missed the rating sync in September, perform an adjustment on a case by case basis 	<p>WL/RK to review Fall divisional results and determine if ratings for individual players need to be adjusted – this will be done on a case by case basis</p>
